Youth Concerto Competition Rules

1. High School is open to students in 9-12th grade, one winner may be chosen. Middle School is open to students 6-8th grade, one winner may be chosen. Former winners must wait at least 12 months to apply for the same division.
2. The competition is open to all instruments.
3. All applicants should be prepared to play **one movement** of a concerto, or a single-movement work written for solo instrument and orchestra.
Option for auditioning with a complete (multi-movement) concerto: Applicants may elect to submit a complete concerto for the Audition Committee's consideration. If the Committee approves the selection, the applicant will be asked to play one entire movement of the concerto for the audition, and, at the Committee's discretion, portions of other movements. (Extra audition time will be allotted for multi-movement concertos.) If an applicant auditioning on a multi-movement concerto is chosen as the winner in either division, the BSO may elect to program either the entire concerto or only a single movement.
4. The BSO has a limited budget for parts and scores. Soloist music selection is subject to approval. The piece selected should be readily available for purchase or hire.
5. Where a cash prize is awarded this will be the same prize for both single movement or complete concerto performances. The Audition Committee can decide not to award prizes, if appropriate as determined by the Committee.
6. All applications must be complete, including completed application form, letter of recommendation and application fee, and received by published deadline.
7. Application fee is non-refundable.
8. Transportation to or from the audition is not provided.
9. All auditions must be in person. Audition places are available on a first come-first served basis. Notification of audition time will be sent EMAIL at least one week prior to the audition date.
10. Audition dates, times and location are not negotiable. Once the audition spots are filled, a waitlist will be started and applicants notified accordingly.
11. All auditions will take place before an audition committee.
12. Where the name of an accompanist is included in the application the BSO will try to ensure consecutive audition times for applicants using the same accompanist. **THIS CANNOT BE GUARANTEED.**
13. An alternate audition date will be provided in the case of severe inclement weather.
14. Applicants must supply their own accompanist for the audition. One piano is available for accompaniment.
15. Applicants will be judged on their mastery of their instrument as well as their stage presence.
16. Audition results will be communicated within three weeks after the audition date.
17. The 1st place winner of the both Middle School and High School will be invited to perform with the Broomfield Symphony Orchestra at the concert scheduled for May 23rd, 2019.
18. Winners agree to provide a headshot and bio that will be used by the BSO for marketing purposes.
19. This policy can be amended at any time without prior notice.
20. The decision of the Audition Committee is final.
21. Failure to abide by these rules and regulations may result in the applicant's disqualification.
